HCCI has access to Medicaid and Medicare data that CMS makes available to product innovators; data that contains clues on how you can make the health care system work better. For example, we can use government data to provide insights on spending and use of particular services or types of care, quality of care, provider profiling, or value-based payment. And unlike work that draws on commercial claims dataset, reports we create for you from Medicaid and Medicare data do not need to be made public.



Glean insights from your claims data. Health care claims data is the most comprehensive source of real-world evidence available to researchers – the gold standard for timely, population-level information. HCCI can help you unlock the valuable information buried deep within the numbers: analyzing your claims data ourselves, providing training and technical assistance to others, or expanding our existing multi-payer claims database with your records.
